



CONTRIBUTOR'S AGREEMENT

Please read this Agreement in its entirety before submitting content ("Article(s)") to Strain Insider. By submitting Articles to Strain Insider for publication, YOU agree to and are bound by this Agreement.

This Contributor's Agreement ("Agreement") is entered into between the undersigned Contributor ("YOU") and Strain Insider Media LTD (here as Strain Insider) as follows:

1. YOU agree, at your sole expense, to prepare, and to submit to Strain Insider, one or more Article(s) for review and possible acceptance by Strain Insider (in its sole discretion) pursuant to Section 2 below. If the Article is not acceptable to Strain Insider, Strain Insider may, in its sole discretion, give YOU a chance to revise it. YOU also agree to abide by the terms of the StrainInsider.com Contributor Guidelines (the "Guidelines"), as amended from time to time, which are incorporated herein by this reference. YOU also agree to periodically check the Guidelines for any amendments.
2. YOU understand and agree that Strain Insider is under no obligation to accept any Article YOU submit and, if accepted, may decline to publish such Article or discontinue publication of such Article at any time, with or without notice.
3. For good and valuable consideration, YOU hereby irrevocably transfer and assign to Strain Insider, absolutely and with full title guarantee, all rights, title (including ownership) and interest in and to each Article accepted hereunder by Strain Insider and its Affiliates, licensees, sublicensees and other designees, and its and their respective successors and assigns (collectively, "Strain Insider Designees") shall have all rights, title (including ownership) and interest in and to each Article accepted hereunder by Strain Insider, including any photographs, illustrations, tables and other graphics (collectively, "Images"), which were created or prepared specifically for the Article with which they are included. In the event that YOU include with any Article YOU submit to Strain Insider any such Images which were not created specifically for inclusion in such Article (collectively, "Your Images"), YOU retain ownership rights therein but hereby grant Strain Insider a worldwide, royalty-free, nonexclusive right and license in perpetuity to reproduce, display, publish, sublicense, distribute and otherwise use Your Images as part of the Article, with which they were included, or as part of excerpts or any promotions of any such Article (collectively, "License Rights"). The rights, title and interest YOU grant Strain Insider in and to any Article accepted hereunder by Strain Insider and the License Rights in and to any of Your Images as part of those Articles shall include without limitation the exclusive worldwide right: (a) to register copyrights in such Article in the name of Strain Insider or any of Strain Insider's Designees; and (b) the right of Strain Insider and its Designees to publish, display, distribute or otherwise use all or any portion of the Article (i) in the original language prepared by YOU or any other language, (ii) in any and all countries and regions throughout the world, and (iii) in any and all forms, formats and media, now known or hereafter developed, including without limitation print, electronic, audio, video, broadcast media, film and other performance media, computer-accessed databases and content feeds, and in such forms as compilations, adaptations, serializations and syndications. Strain Insider shall identify YOU as the author in the byline, and in Strain Insider's copyright registration, of any Article accepted hereunder. YOU also hereby irrevocably waive, to the extent permitted by applicable law, all claims YOU may now or hereafter have in any jurisdiction to any and all rights of paternity, integrity, disclosure, and withdrawal, and to any other

rights that may be known as "moral rights", with respect to any and all Articles submitted by YOU and accepted by Strain Insider. (As used herein, "Strain Insider's Affiliates" means any party, which directly, or indirectly through one or more intermediaries, controls, is controlled by, or is under common control with, Strain Insider.)

4. Notwithstanding Section 3 above and as part of the consideration for the rights irrevocably transferred to Strain Insider, Strain Insider hereby grants YOU a nonexclusive, worldwide, royalty-free, and non-transferable right to publish or otherwise reproduce, in whole or in part, any Article accepted hereunder by Strain Insider: (i) on website(s) YOU own or operate, (ii) in publications, of which YOU are the sole author, (iii) as part of your own seminars or other speaking engagements, and (iv) in any other media now known or hereafter developed, for which YOU are providing the only content, conditioned on the following: (a) YOU will not publish or otherwise reproduce all or any portion of the Article until Strain Insider has first published the Article for a continuous period of not less than ten (10) days in any print publication or online media outlet owned or operated by Strain Insider or any Strain Insider Affiliate; and (b) your publication or other reproduction of the Article (in whole or in part) is at all times accompanied (i) by the following notice of copyright registration and, (ii) if reproduced electronically, by a link from that notice to the initial page of the same Strain Insider website, on which the Article first appeared:

Copyright [year of first publication] by Strain Insider. All rights reserved.

5. Strain Insider may modify, edit and/or take excerpts from any Article accepted hereunder, in order to meet its editorial or space requirements. If Strain Insider makes any material changes in the Article and if its production schedule permits, it may send YOU a copy of the edited manuscript to check for accuracy. YOU must review and provide any required changes by the deadline stated by Strain Insider. Strain Insider may accept or reject (in its sole discretion) any changes suggested by YOU.

5. Without notice to YOU and without your prior approval, Strain Insider and any of its Designees may, in its/their sole discretion, modify, edit and/or take excerpts from any Article accepted hereunder, in order to meet its editorial or space requirements. If Strain Insider makes any material changes in the Article and if its production schedule permits, it may send YOU a copy of the edited manuscript to check for accuracy. YOU must review and provide any required changes by the deadline stated by Strain Insider. Strain Insider may accept or reject (in its sole discretion) any changes suggested by YOU.

6. YOU warrant and represent that: (a) YOU are entitled to transfer and grant Strain Insider the rights specified in this Agreement; (b) the Article is your own original work, has not been previously published or otherwise reproduced in any medium, and will not infringe or plagiarize the work of any other person or entity. YOU warrant and represent that YOU have exercised reasonable care to ensure that the information contained in each Article is accurate and does not contain any untrue statements or material that is deceptive, fraudulent or intentionally misleading, or which is defamatory or which invades or otherwise violates any third party's rights. YOU also agree to retain, for a period of not less than three (3) years after first publication by Strain Insider, all materials used in preparing each Article accepted by Strain Insider, regardless of the specific medium in which prepared or stored and including without limitation all notes, memoranda, letters, e-mail messages, and audio or video recordings. YOU also agree: (a) to assist and cooperate with Strain Insider or any of Strain Insider's Affiliates or any licensees or other designees, and its and their respective successors and assigns (collectively, "Strain Insider Parties") in the defense of any legal action brought against Strain Insider or any such Parties, arising from the publication of your Article(s); and (b) to indemnify and hold harmless Strain Insider and any of the Strain Insider Parties for any loss or expense (including reasonable attorneys' fees) incurred if any warranty or representation made by YOU in this Agreement is found to be incorrect.

7. YOU warrant and represent that YOU have disclosed to Strain Insider in writing any financial relationships that may exist between YOU and the companies or individuals that YOU have written about or linked to in the Article(s). YOU further warrant and represent that YOU have received no remuneration, consideration or compensation of any kind whatsoever from any third party for the creation of any Article(s) submitted under this Agreement, including without limitation any remuneration, compensation, or consideration of any kind whatsoever from any companies, or other third parties whose identities, products or services are mentioned, discussed, or otherwise appear in any Article(s) submitted under this Agreement. YOU understand and agree that receiving any form of remuneration, consideration, or compensation of any kind whatsoever from any third party shall be considered a breach of this Agreement.

8. If YOU breach the terms of this Agreement, Strain Insider shall have the right, without any liability whatsoever, to terminate this Agreement, effective immediately and to remove any and all of your Article(s) being published by Strain Insider or any Strain Insider Parties under this Agreement, in addition to such other rights and remedies as Strain Insider may have under applicable law.

9. YOU understand and agree that Strain Insider cannot prevent third parties from downloading, reproducing, editing, distributing or retransmitting any of the Articles accepted hereunder by Strain Insider. YOU and Strain Insider shall each be solely responsible (but under no obligation) for protecting or enforcing your/its own rights, title or interest (collectively, "rights") in each Article (if accepted by Strain Insider) against any third party, and at your/its sole expense. Should YOU or Strain Insider take any action to protect or enforce those rights, the other party agrees to assist in any such action, upon written request and provided that said request is reasonable in terms of the time and effort required and involves no financial contribution or unreimbursed expenditure.

10. Neither Strain Insider nor any of the Strain Insider Parties shall be liable or otherwise legally responsible to YOU for any and all claims, damages, expenses, fees, or injuries of any nature whatsoever, arising out of, or in any way related to, any Article accepted hereunder by Strain Insider, whether by Strain Insider, any of its Affiliates, or its or their respective successors, assigns, licensees or other third-party designees and regardless of the media or jurisdiction in which published or otherwise reproduced.

11. YOU hereby grant Strain Insider and the Strain Insider Parties the irrevocable, nonexclusive, worldwide and fully-paid right to use your name, likeness, biographical information, and/or voice (the latter, for example, in a video clip or sound file) in any legal manner and in any form, format or media now known or hereafter developed, to promote any of the Articles accepted hereunder by Strain Insider and/or the specific media through which such Articles are being distributed, whether by Strain Insider or any Strain Insider Parties.

12. This Agreement shall take effect on submission of your Article to Strain Insider and, if your article is accepted by Strain Insider, shall remain in effect for the life of Strain Insider's copyright ownership therein, regardless of if or when published by Strain Insider and, if published, continuing after Strain Insider has ceased publication thereof.

13. YOU acknowledge and agree that YOU are an independent contractor and not an employee or agent of Strain Insider or of any Strain Insider Parties. Nothing in this Agreement shall be construed to create an employer-employee relationship between YOU and Strain Insider or any Strain Insider Parties.

14. This Agreement contains our entire understanding and may not be modified, waived or discharged orally. Any modifications, waiver or discharge of any of the terms of this Agreement must be in writing

and signed by both parties. The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provision.

15. YOU acknowledge that YOU have read this Agreement, understand its contents and have had the opportunity to have this Agreement reviewed by your legal counsel.
